

# TERMS AND CONDITIONS

## LICENCE AGREEMENT

By using the SB ELECTRONIC SYSTEMS software program supplied to you, you agree to the terms and conditions of this Licence Agreement.

- 1. GRANT OF LICENCE.** In consideration of payment of the LICENCE fee or fees which is part of the price you paid for this product and your agreement to abide by the terms and conditions of this Licence and the Limited Warranty, SB ELECTRONIC SYSTEMS LIMITED (hereinafter referred to as SB ELECTRONIC SYSTEMS), as Licensor, grants to you, the LICENSEE, a nonexclusive right to use and display each copy of the SB ELECTRONIC SYSTEMS software program (hereinafter referred to as the SOFTWARE) on a single computer (i.e. with a single CPU) at a single location so long as you comply with the terms of this Licence. SB ELECTRONIC SYSTEMS reserves all the rights not expressly granted to the LICENSEE.
- 2. This Licence is not a sale of the original SOFTWARE or any copy.
- 3. COPY RESTRICTIONS.** This SOFTWARE and the accompanying written materials are the subject of copyright. Unauthorised copying of the SOFTWARE, including SOFTWARE which has been modified, merged, or included with other SOFTWARE, or of the written materials is expressly forbidden. - 7. UPDATE POLICY.** SB ELECTRONIC SYSTEMS may create from time to time updated versions of the SOFTWARE. At its sole option SB ELECTRONIC SYSTEMS will make such updates available to the LICENSEE and transferees who have paid the annual Support and Maintenance fee to SB ELECTRONIC SYSTEMS.
